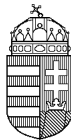

10:30-12:00 **Session 1: EU LNG strategy – Does one size fit all?**

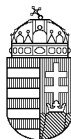
The EU published its LNG and gas storage strategy on 16 February with the main conclusion that the creation of liquid and competitive markets to enable LNG is indispensable to achieving a real Energy Union. The document also stated that while some member states already enjoy mature and liquid gas markets, Central and South-Eastern Europe remains heavily reliant a single supplier and exposed to supply disruptions. This session is intended to discuss how the Danube Region could be integrated to the global gas market by gaining access to the LNG sources.

13:30-15:00 **Session 2: What role can the Danube Region play in the LNG-revolution?**

Some LNG projects are regarded from a security of supply perspective, some consider them as profit-oriented ventures of complex economics, where the involvement of public funding seems inevitable. The recently published LNG strategy of the EU demonstrates that political will for supporting EU-wide LNG initiatives exists. Now it is up to the business sector to identify the missing puzzles in order to make these projects commercially viable. This session intends to determine the key drivers (tariff, well-defined infrastructure projects, regulatory measures, interconnections, etc.) that could further attract the involvement of the private sector in LNG projects.
